Soil Nails and Anchored Tie Backs

Because the bars are grouted the full length of the bar they are a passive anchor system, meaning that there must be a small amount of movement in the anchor in order to mobilize resistance A soil nail wall is constructed by first installing a single row of soil nails in an excavated

Self-drilling hollow bars are ideal for soil nailing (see figure 1) as the soil is generally soft, allowing a slender bar to penetrate with relative ease Soils
